1. Parliamentary protest movements, c. 1830 - 1848.

Study the two sources below and answer the question which follows.

Source A

‘Reports show that an entire change in society is contemplated by the working classes. They aspire to be at the top instead of at the bottom of society – or rather there should be no bottom or top at all.’

Source B

‘The menace from Chartist was far less than that of the radical reformers of 1831-1832. Now that the middle classes were securely hitched to the constitution, Members of Parliament had no reason to vote from fear or worry.’

2. Social Change, c. 1830-1848.

Study the two sources below and answer the question which follows.

Source A

'This committee would observe that in the midst of what appears to be a wealthy, spirited and flourishing community, a vast multitude of poorer fellow subjects are condemned to the evils of disease and misery and placed in situations where it is impracticable for them to preserve health and decency and to keep themselves and their children from physical or mortal contamination.'

Source B

'Quite apart from governmental policy, the inherent vitality of an expanding economy was sufficient to carry the country safely through the storms which made Europe the centre of revolution in 1848. By 1850 the Annual Register could comment, without undue optimism, on the improved living and working conditions and the tranquility and cheering future of the British nation.'
