The question will attract a one-sided approach, although better candidates might recognise the limitations of science fiction.

It is important that an answer focuses on the appeal of the films chosen, rather than merely describing them.

- $\Rightarrow$  Escapism appeals to the imagination
- $\Rightarrow$  Belief that a real future is being presaged
- $\Rightarrow$  Human fascination with and fear of monsters/'the other'/the unfamiliar
- $\Rightarrow$  Link between film and book
- $\Rightarrow$  Historic Sci Fi films still fascinate audiences (e.g. *Frankenstein*)
- $\Rightarrow$  Encourages speculation
- $\Rightarrow$  A way to explore eternal moral themes (e.g. *Star Wars*)

## 14 What do you consider to be a 'good read', and why? Refer to at least <u>two</u> novels with which you are familiar.

Better answers will explore the meaning of 'play', taking it beyond the mere participation in a usual range of games.

[A definition of 'play' is desirable]

- $\Rightarrow$  Natural exploration of the world by the baby
- $\Rightarrow$  A way to build/develop relationships (at all ages)
- $\Rightarrow$  Children often 'role play' so do adults
- $\Rightarrow$  Outlet for energy
- $\Rightarrow$  Expression of joy
- $\Rightarrow$  Adults can stay young by playing
- $\Rightarrow$  There are games of the mind as well as the body
- $\Rightarrow$  Distinction between amateur and professional play
- $\Rightarrow$  Teenagers' partly playful identification with 'heroes'
- $\Rightarrow$  Play in later life can limit the ravages of age
