# INSTRUCTIONS AND GUIDANCE FOR TEACHERS AND CANDIDATES TAKING EXTERNALLY ASSESSED ASSIGNMENTS

#### The externally assessed assignment

The assignment must be taken during the two-week assignment period. It may be taken as one 6 hour session or in up to four  $1\frac{1}{2}$  hour sessions. Each session must be a multiple of  $1\frac{1}{2}$  hours.

#### Preparing for the assignment

Candidates will sit the assignment under examination conditions. The preparatory folder, which must contain only notes written by the candidate and material collected from the organisations studied, must be collected by the teacher **before** the two-week assignment period begins. The folder will be given out at the beginning of each controlled conditions session and be collected in with the scripts at the end of each session and kept securely by the teacher between sessions. Nothing may be added to the folder during the two-week assignment period and no other material may be taken into the examination session(s).

#### Writing the assignment under controlled conditions

The assignment consists of four tasks, each designed to be completed in  $1\frac{1}{2}$  hours. Each task is to be written in a new answer book. At the end of each  $1\frac{1}{2}$  hour session, the answer book containing one completed task will be collected and kept securely by the teacher until the end of the final session. No alterations or additions may be made to candidates' answers to each task once the session has ended.

At the end of the final (fourth) session, the four answer books for each candidate must be fastened together and sent to the designated examiner with the appropriate Centre Declaration Sheet, etc. The preparatory folders must be kept under secure conditions until after the Enquiries upon Results deadline. AQA may call for these preparatory folders to be made available at any time during this period.

#### Assignment Task 1: Location





Figure 1 – Brindleyplace Leisure Plan

Study **Figure 1 and Figure 3** on the insert, which show Brindleyplace and the Ikon Gallery in Birmingham.

Brindleyplace lies on the edge of the city centre. It is a former industrial area which has been totally redeveloped during the past fifteen years. Much of the development consists of high-rise offices, most of which are used for banking and financial services, media and management.

The Ikon Gallery is an internationally-famous contemporary modern art venue situated in Brindleyplace. The Ikon is an educational charity, which aims 'to encourage public engagement with contemporary art through exhibiting new work within a context of debate and participation'.

#### Assignment Task 2: Refurbishment

Study **Figure 2 and Figure 3** on the insert and read the extract below. The extract is adapted from 'From Primary School to Art Gallery', a short history of the building that houses the Ikon Gallery, written by Dr Chris Upton.

The Education Act of 1870 ... led to an explosion of school building throughout the country ... In Birmingham a total of 28 new schools was built and one of them was Oozells Street School ... in a crowded area of small industrial works and back-to-back housing...

In the early 1990s, whilst Oozells Street School was looking for a new owner, across the city the Ikon Gallery was searching for a new home. Founded in 1963 by a small group of artists, Ikon had grown to occupy a warehouse ... But this space too had become too small and was unable to suit visitors' needs. The solution seemed obvious but it took a lottery grant of £3.7 million to make it happen, plus the offer of the site to Ikon at a very low rent by the developers.

What the architects did was to preserve the outside shell of the old school building and put an entirely new, steel-framed gallery inside. A total of 440 square metres of gallery space where children once did their sums! Anyone who remembers what the interior of the school used to look like will be in for a big surprise.

On the outside the changes were in keeping with the original. The Victorian tower was rebuilt to its original design, skilfully reworked from old photographs. In addition, a scenic glass lift and stairway as well as a service lift have been built on the outside of the building to allow maximum gallery space within. An important innovation, suggested by an artist who worked directly with the architects, was to set the building apart from its surroundings on a dramatic slate plinth. In this way the gallery refuses to be dominated by the high-rise office blocks around it.

And so Oozells Street School is re-born...

(a) (i) Suggest reasons, **other than** its location, why the Oozells Street School was a suitable building for conversion into an art gallery.

(ii) Describe **two** of the changes that were made when the building was converted, and explain why they were necessary.

(6 marks)

(b) Choose a leisure facility that you have studied which has been refurbished.

Evaluate the success of the refurbishment.

  - electrical/computer requirements
  - eating or vending facilities
  - refuse disposal
  - car parking
  - emergency exits.

Evaluate how well the design of **each** of your chosen aspects fulfils its intended function.

  - evaluate the efficiency of these arrangements.
