Cupcake Joy was started by housewife Vanessa Naylor in 2005, with the objective of earning a profit of £3000 per year by working part-time. Based at home, Vanessa has been successfully supplying high-quality cupcakes to local customers for weddings and birthday parties. As Vanessa has gained customers, it has been increasingly difficult to actually produce enough cupcakes at home. With ingredients and packaging piled up around Vanessa's house, production is becoming very inefficient.

Now that her husband has retired, Vanessa wants to expand her business and has decided to hire a small local industrial unit where she plans to bake and decorate her cakes. She will form a private limited company and take on a school leaver to help, full-time, with the production of the cakes. Vanessa plans to pay her trainee the minimum wage because she needs to keep her costs as low as possible. However, since the work will be fairly simple and very repetitive, Vanessa is worried about how to motivate the trainee.


1	(d)	Vanessa is trying to work out the best way to motivate her trainee. She is considering:

Entrepreneur Mike Cox was worried about youth unemployment and the lack of leisure activities for young people in his local area. He decided that starting a social enterprise could help solve these problems. He was encouraged when he saw a leaflet about local government grants. They offered up to £5000 to a limited number of small businesses in his area who could prove that they would create local jobs. Mike's plan is to start a social enterprise that arranges concerts for local DJs to help them reach a wider audience. He believes that this will give youngsters something to do and will create employment opportunities for local DJs. Mike plans to run 24 events in the first year of the business. He organised a focus group among a few friends and got a generally positive response.

Despite the findings from his market research, Mike decided not to use Twitter to promote the events – he will use posters in the local area instead. He insists that he wants to run the business as a sole trader and has already asked friends and family for loans – but with no success.
