Source A: Twitter user sentenced for sending death threats



Facebook and Twitter can assist with community cohesion. However, some people misuse social media.

A Twitter user has been jailed after sending death threats to another person.

Caroline Criado-Perez received threatening messages because she successfully campaigned to have a picture of a woman put on new £10 notes. Caroline wanted to make sure that British banknotes support equality by showing the faces of both women and men.

Soon after, the abuse began. Caroline was bombarded with offensive and menacing tweets, leading to a police investigation.

Source B: Census denies Welsh people their identity



The census is an official count or survey of the population. Each household in the UK must fill in a form every 10 years with information about themselves and their way of life.

The UK is made up of England, Scotland, Wales and Northern Ireland. Each has its own identity and culture. The census helps the government learn about diversity in the UK.

The 2011 UK census form allowed people to identify themselves as English, Scottish or Irish as their ethnic group. However, there was no option for people to identify themselves as Welsh even though there had been a campaign for Welsh to be included.

Source C: Angry protests over 'bedroom tax'

Changes to the benefits system have led to protests. People who claim housing benefit but have a spare bedroom in their home will have their benefit cut. This has been nicknamed the 'bedroom tax'. The government believes people should move to smaller cheaper properties. Government ministers believe this will reduce the housing benefit bill by £500 million.

However, some people argue that this will unfairly affect people on low incomes and minority groups such as the disabled. They believe the 'bedroom tax' is a form of discrimination.

The United Nations has sent an inspector to Britain to check whether people affected by the bedroom tax still have an adequate standard of living.



Source D: Illegal immigration

The UK Border Agency has launched a campaign to encourage people who are not allowed to stay in the UK to return home.

- The campaign offers help to people from all over the world to get home, for example, by helping to book plane tickets.
- A spokesperson said that this campaign was already working and more effective than arresting illegal immigrants.



Source E: Teenagers banned from school for refusing to shave their beards



Two Muslim pupils have been banned from school classes for refusing to shave off their beards. The school said the two 14 year olds broke its dress code.

A relative said "They are not being allowed to mix with anybody or speak to friends. It is pure discrimination. The school has to have an open policy and they have to take in people from all religions."

The headteacher said "We have not taken this decision lightly. I have researched the issue and spoken to Muslim elders. There is nothing in the Koran about wearing a beard. It is a choice the boys are making. We believe that it's important to maintain high standards in every aspect of school life, including appearance and uniform. Pupils and parents are often reminded of the rules and know that they apply to everyone.
