## Section A – Analyse and Interpret Different Types of Evidence

### Document A

#### The causes of the British Airways (BA) dispute

In May 2009 BA announced its biggest ever loss in one year, £513 million. It also announced it needed to permanently reduce its costs.

In November 2009 BA proposed to do this by:

- cutting the numbers of cabin crew on long distance flights
- a two year pay freeze
- new contracts for new staff paying much less to new staff than existing staff

The trade union Unite which represents BA employees claimed this would:

- hit passenger service on flights
- reduce employee earnings
- limit employee career prospects

Strike action started in March 2010 after the union asked its members to vote on the issue.

### Document B

#### Unite Ballot Result

In February 2010 the Unite trade union announced the results of its vote on the issue of strike action at BA.

Number of voting papers issued	11 691	100%
Number of voting papers returned	9271	79%
Number supporting strike action	7482	81%
Number not supporting strike action	1789	19%

Unite hoped that this large vote in favour of strike action would influence BA. Unite did not set any dates for action to start. It hoped BA would try to settle the dispute through negotiation.

BA responded “We will not allow Unite to ruin this company.” It also threatened that any workers who took part in strike action risked losing their generous BA travel perks.

**Document C****Trade Union Rights**

A trade union is an organisation of workers that tries to protect its members by negotiating with employers on pay and conditions of work.

Individuals are free to join – or not join – a trade union. They should not be treated differently because they are, or are not, a member of a trade union.

Employees should not be treated unfairly because they take part in union activities. Unfair treatment would include dismissal or subjecting a worker to a penalty.

Penalties could include:

- withholding a pay increase
- not giving a promotion
- refusing a transfer or training opportunities

### Document D

#### The Status of Women in Islam

Women are recognised by Islam as full and equal partners of men in the creation of life.

### Document E

#### Women Bishops Could Split the Church

The Church of England could split if women become bishops. As many as 1300 male priests say they will leave if this happens.  
 When women were allowed to become priests in 1992, around 450 male priests joined the Roman Catholic Church. Some of those who opposed women priests stayed because they were allowed to opt out of having anything to do with women priests. This opt-out will now be withdrawn.  
 This is a struggle between those who support justice for women and those who support the traditional view that only men can be priests.  
 Some women believe that, by appointing women bishops, the Church will split itself apart and call on it to hold back.

### Document F

#### Prejudice and Discrimination

Prejudice is an opinion which is often not based on fact. It can be caused by differences of religion, race, colour, sex, language, disability or age.  
 Discrimination can happen when someone who is prejudiced has the power to express their prejudice.  
 Christians believe that all people are equal in the eyes of God and should be treated equally. Some believe the Christian Church is sexist and does not treat men and women equally.  
 In Islam the Qur'an states that everyone was created by Allah and therefore all are equal. This applies to men and women who are equal in the sight of Allah. Although men and women are equal, they are not the same.
