Scenario

StudentBounty.com As an employee of "Super Supermarkets", you have recently completed the IMIS Higher Diploma and as a result, been promoted to take over a project which involves the introduction of a home grocery delivery service. The necessary re-work resulting from the failure of the acceptance tests is making the situation worse.

The project sponsor, who is also the marketing director, insists that deadlines must still be met, as it is crucial not to fall any further behind business competitors. The project sponsor is keen for you to take over. You have a good record as a developer and with your new found skills, he feels that this project should provide an excellent challenge for you.

The sponsor has arranged for a one-to-one meeting in two weeks time with you to discuss the project.
