#### Scenario 1

Student Bounty Com Konrad and Heidi have been married for eight years and have one child, Elsa, aged six. Konrad works as a consultant for a car manufacturing company. Seven years ago, Konrad and Heidi moved from the North of England to the South when he was offered a very good salary of £150,000. The company also provided a fully furnished home, rent free and a top of the range company car.

Heidi was proud of her husband, willing to leave her friends and family and to give up her own career to start a family and support her husband's career. Heidi agreed that they would make their permanent home in the South of England. Heidi has been a homemaker and stay at home mum since Elsa was born.

Before they moved, Konrad promised Heidi she could visit her family whenever she wanted. He also said he would help her return to work when their first child was old enough to go to school.

After they moved, Heidi found that Konrad was away from home for most of the day and often much of the night too, entertaining clients. Initially, Heidi and Elsa visited her family in the North regularly. When Elsa started school, Konrad said that Heidi was no longer allowed to take her to the North of England more than once a year as the journey was too long and he felt this would interfere with her schooling and making friends. Now that Elsa is six Heidi would like to go back to work. Konrad insists that Heidi cannot go back to work because she should be at home for Elsa.

Heidi feels isolated, bored and frustrated and finds the more she tries to talk about this to Konrad the longer he stays away from home and ignores her. Konrad also withholds money from Heidi if she irritates him and she has no access to their bank accounts.

Heidi is unhappy and is thinking of taking Elsa and moving back to the North of England, which is an eight hour drive from their family home in the South.

#### Scenario 2

SHIIDENT BOUNTY COM Pavel and Nadya have considered themselves as good as married sin went through an informal ceremony with friends on a holiday three years when they were both 17. The couple live together in a house which is in Pave name although Nadya paid half the deposit and contributes to the mortgage. Pavel is a youth worker and Nadya is a nurse, their salaries are similar.

Pavel and Nadya have one child, Sasha who is two years old. Pavel was working at a youth camp in America when Sasha was born. Pavel helped Nadya choose her name before she went to register the birth but he was very sad to not be there with them. Pavel did not meet his daughter for the first time until she was three months old. Since returning home Pavel has developed a very close relationship with Sasha. He has found a job locally and has altered his working hours so that he can look after Sasha when Nadya is at work.

Pavel and Nadya's relationship has become increasingly strained. After some months of arguing, having realised they are no longer in love, Pavel and Nadya have separated. They are both still living in the family home to share the care of Sasha. Pavel tells you that the atmosphere is unsettling for Sasha and he seeks your advice on a number of matters.

#### Scenario 3

Salina does not wish to be divorced, her religious beliefs and those of her community disapprove of divorce and she fears she may be rejected by her family and friends.

Salina has never worked as she moved straight from her father's home to Ben's and has always been provided for. Salina left school at 16 with no qualifications, skills or training for the workplace. Ben owns an import business and draws an income of around £90,000 a year from this. He has a pension and the house they live in is registered in Ben's name only. Salina is currently still living with Ben because her father has refused to allow her to return home to live with him and she has nowhere else to go.
