## SECTION B (Answer at least one question from this section)

### **Question 1**

StudentBounty.com After a night out in town with their friends, Joanna and Sian decided to go for a meal in a late night restaurant, despite knowing that they did not have enough money to pay for the meal.

They chose seats near the door and ordered their meals. As time went on, the restaurant became very busy. Joanna and Sian ate their meals and, when they thought that they would not be noticed, they got up and walked out without paying.

On the way out, Joanna took a jacket, which was not hers, from the coat rack. Joanna put the jacket on and they walked a short distance from the restaurant and decided to check the pockets of the jacket because they needed money for a taxi home.

Inside a pocket they found a wallet containing a small amount of money and a bank debit card; there was also a bunch of keys in the pocket. Sian used the debit card to try and withdraw more money out of a nearby cashpoint machine. Sian was unable to withdraw any money as, after three failed attempts, the machine kept the card.

They found the owner's address in the wallet and decided to go to his house. Once there, they used his keys to enter the house and had a look to see if there was anything that they could steal to sell for money. They found a laptop and an Ipod and decided to leave the house at that point, with the items, in case the owner returned and caught them. Joanna kept the jacket.

Consider Joanna and Sian's criminal liability for their actions.

# **Question 2**

Discuss the criminal liability of Ben, Tom and Darius in the following sca together with any possible defences that could be available to them.

A woman knocked Ben's arm as she tried to pass him and he turned and said, "Watch out, I'll kick your head in if you do that again." As he made his way back to his friends, he pushed Rob, another customer, causing Rob to spill his drink.

(b) Clare was with her boyfriend Tom in a nightclub. Tom had gone to the toilet so Dean started speaking to Clare. Tom could see Dean whispering in Clare's ear as he made his way back to her. In a jealous rage, Tom smashed a bottle on the bar and lunged at Dean with the broken bottle, causing deep lacerations to Dean's face. These injuries needed cosmetic surgery and a number of internal and external stitches.

(c) Darius and Abdul had gone to watch a football match. A scuffle broke out alongside them. Darius saw that Abdul had been assaulted and he thought that the man who had assaulted Abdul was going to assault him again. Darius grabbed the man and punched him repeatedly to the stomach to stop him from attacking Abdul. The man suffered bruising to the ribs.

#### **Question 3**

Creighton and Marcus had been in a civil partnership for a number of year Creighton discovered that Marcus was having an affair with Gary.

#### **Question 4**

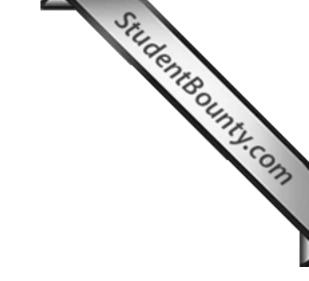
Discuss the criminal liability of Imran, Kylie and Fred.


