Attendance on Mr William Allen who is a new client. I obtained the proof of identity documentation and carried out the usual conflict checks. There are no issues. His details are as follows:

Mr Allen wanted advice about his options following the breakdown of his marriage. His wife is Francesca Allen (d.o.b. 07/01/1975). The couple have been married for ten years. Mr Allen had brought in his marriage certificate, which he handed to me.

He and his wife have two children: Bryony Allen (d.o.b. 23/06/2006) and Quinn Allen (d.o.b. 17/09/2008). The parties' matrimonial home is 3 The Laurels, Clayton, Barnardshire, BH11 4OT. It's a four-bedroom semi-detached property held in the couple's joint names. Both parties are currently still living at the property. Mr Allen is an architect, who is in practice in Clayton. His wife is a health and safety officer with the local Council.

Mr Allen explained that there had never been any problems in the marriage until early 2013 when he started to suspect that his wife Frankie was having an affair. She was routinely returning home from work later than usual in the evenings and was always checking her mobile phone. In February 2013, Frankie announced that she was going away for a spa weekend with her friends. Mr Allen thought it was a little odd as his wife had always been dismissive of spa treatments in the past but he had agreed to her going on the trip. The spa weekend took place on the first weekend in March. On the Saturday afternoon, while his wife was away, Mr Allen had taken the children to a local adventure playground. Unfortunately, Quinn had fallen from one of the swings and fractured his wrist so Mr Allen had to take Quinn to the Accident and Emergency ward of the local hospital for treatment. While he was at the hospital, Mr Allen telephoned his wife's mobile but found that it was switched off. He then telephoned the hotel where his wife had said she was staying but they told him they had no record of her being a guest with them. When he telephoned one of the friends that his wife was

supposed to be away with she told him that she had no idea where Fi and that she didn't know anything about a spa weekend.

She broke down in tears and admitted that she had been having an affair with a colleague from work (Paul Roberts) and she had been away with him that weekend, but that she now realised that she had made a huge mistake. She begged Mr Allen to forgive her. Mr Allen told me that he had decided to reconcile with his wife, partly for the sake of the children.

He confirmed that things had then seemed to return to normal for a number of months although he noticed that by the end of November 2013 his wife was receiving lots of text messages on her phone. On December 23rd Mr Allen was helping the children to wrap their presents for their Mum. He had needed a pen for the labels so was looking in Frankie's handbag when he came across a jewellery box containing a pair of earrings. There was a gift card in the box which read "To my darling Frankie, sorry that I can't spend Christmas with you, all my love Paul". Mr Allen immediately confronted his wife about his discovery. She admitted that she had started seeing Paul again in early November 2013 but she promised that she would now end the affair.

Mr Allen told me that he had moved into the spare room from that night onwards. He believes that his marriage is at an end and would like to start divorce proceedings as soon as possible.

Telephone attendance upon Mrs Singh. I confirmed that she would shortly receive the decree nisi, to be pronounced in relation to her two-year separation petition.

Mrs Singh told me that she had spoken to the valuer who was carrying out the joint valuation on the former matrimonial home and he had suggested a valuation of £450,000. The valuer confirmed he would send through written details of this valuation to me and Mr Singh's lawyer, shortly.

I ran through the up-to-date figures for the parties' assets with Mrs Singh:

- Former matrimonial home: 15 Grosvenor Close, Clayton (Land Registry Title Number BD56410) held in Mr Singh's sole name, valued at £450,000 less mortgage of £150,000; net equity £300,000
- Investment property: 7 Central Avenue held in Mr Singh's sole name and valued at £110,000 (this property is mortgage free)
- Joint life assurance policy with a surrender value of £40,000
- Shares in Mr Singh's sole name £80,000
- Shares in Mrs Singh's sole name £20,000
- Cash ISAs in Mr Singh's sole name £40,000
- Cash ISAs in Mrs Singh's sole name £15,000

- Mr Singh's pension: C.E.T.V. £150,000 Mrs Singh's pension: C.E.T.V £50,000

Mrs Singh confirmed that her husband Ranjit is continuing to voluntarily pay child maintenance for the couple's two children, Vikram (15) and Uma (13). They also visit and stay with him regularly at his new house. She is anxious to reach an amicable agreement about all of the couple's finances and avoid court if possible, although she does want to remain in the former matrimonial home with the children. I assured her that we would explore all possibilities for agreeing matters but failing that would pursue the application for financial relief that we had made in the petition.

I noted that once I received the formal valuation from the valuer I could meet with Mrs Singh to discuss her financial position and her options. I suggested that she contact me if she had any queries in the meantime.

Hi Jane,

Student Bounty Com I don't know if you remember me but you acted for me in my divorce from my wife Zara back in 1999. We agreed our finances and we had no children so it all went through quite quickly.

I now need your advice on another matter please. After I divorced Zara, in about 2001 I met my ex-partner Yvette Oliver (d.o.b. 10/05/1972). Yvette and I have two children: Ethan (d.o.b. 30/09/2003) and Isla (d.o.b. 08/04/2008). We set up home in the house I'd retained after my divorce from Zara (16 Shotwick Way, Clavton, Barnardshire, BH12 7LY). If you remember you transferred it into my sole name as part of the financial settlement?

Yvette and I started having problems in our relationship in 2010. We seemed to be constantly rowing. One of the issues we would argue about is the fact that she has always excluded me from making any decisions about the children, for example, she chose which primary school to send them to. I wanted them to go to the school around the corner where I went. After all, I was born in Clayton and she comes from Bedford so I figured I knew the place better, but she insisted on sending them to a different school as she knew the Head there. I've also never been able to take them to the doctor or dentist as she said I don't have the authority to do this. I should have known that I was going to have problems from the start, as she registered both Ethan's and Isla's births without any mention of me and gave them both her surname too!

Things got worse between Yvette and me when I lost my job in the summer of 2011. Yvette increased her working hours to work full-time and I stayed at home and looked after Ethan and Isla. I would say that we reversed roles really; Yvette was the breadwinner and I was the stay-at-home dad. I really enjoyed this but Yvette was resentful of how close I became to the kids and how they would come to me, not her, if they needed anything. By the beginning of 2013 I had concerns that Yvette was seeing someone else. She seemed distracted and had no patience with me or the kids. She would go out one or two nights a week saying that she was meeting her friends. She was also reluctant to spend time with me and the children at the weekend and Ethan and Isla started to notice this too.

Things came to a head at the end of October 2013 when I found out that Yvette was indeed involved with another man. No sooner had I found out than Yvette had moved in with him! His name's Joe Richards. She's been living with him at 23 Barratt Drive, Clayton, Barnardshire, BH12 2EW since 15th November 2013. She's seen Ethan and Isla for the day every Saturday since she moved out. I've encouraged this as I know they need to see their Mum. However, last Saturday she told the children that they'd soon be moving to live with her and Joe. The children were really upset; they love their Mum but they're used to me looking after them. I'd never stop them seeing her but I'd be really grateful if I could have an appointment to see you to discuss what's happened so that I know the legal position. Attendance upon Claire Mitchell, who is a new client. She was very distressed and wanted immediate advice following some incidents of domestic abuse. I completed the necessary conflict checks and obtained the proof of identity documentation. There were no issues.

Claire has been living with her partner Peter Lewis (d.o.b. 09/11/82) for seven years. They have two children: Tyler Mitchell-Lewis (d.o.b. 02/05/08) and Kayla Mitchell-Lewis (d.o.b. 21/06/13).

They live at 2 East Terrace, which is a three-bedroom terraced house rented from a private landlord (Vernon Jeffries), in Claire and Peter's joint names. Peter works full-time as a mechanic at a local garage and Claire has recently returned to her part-time work as a secretary following her maternity leave.

Claire told me that over the past six months she had noticed a change in Peter's behaviour. She said that he had become very bad-tempered and moody with her and the children. She had tried to discuss this change in his behaviour with him but this only made him more bad-tempered with her. She thinks that the trigger for this change in behaviour was the birth of their daughter Kayla. Although Claire had been keen to have another child she explained that Peter had not been. He had initially been completely opposed to the idea but a few years after Tyler was born, he seemed to relent. However, soon after Kayla was born, Peter's behaviour changed. Claire admitted that Kayla's birth had put a strain on their finances and also that she had had some problems with Tyler's behaviour since the birth of his sister.

Initially, Peter had been verbally abusive towards Claire. When he lost his temper he would shout at her, accusing her of being a bad mother for failing to control Tyler and blaming her for their financial problems. Frequently during these altercations he would shake her or slap her. Claire was worried about the children hearing these arguments. However, last night matters escalated and the level of violence had shocked and frightened Claire. She explained that she had

got home after collecting Tyler from school to find Peter waiting for the front door. As soon as they got inside the house he started shout swearing at them. It appears that Tyler had broken Peter's mobile phone; did remember telling him off for playing with it that morning. Unfortunately, incident was in addition to Tyler having broken the television set when he knocked it over at the weekend.

Claire told Tyler to go upstairs. She tried to pass Peter in the hall but he blocked her way through. He then slapped her across the face and taking her arm, dragged her into the kitchen to show her the broken phone. Claire said that she had tried to calm him down but she could see that he had lost control. Peter punched her in the stomach repeatedly. She fell to the floor and hit her head, briefly losing consciousness. When she came around, Peter was standing over her with a knife in his hand. Claire saw Tyler come in to the kitchen and run up to Peter. Tyler tugged at Peter's jeans and Peter turned around with the knife still in his hand. At that point the front doorbell rang; it was Claire's mother bringing Kayla home. As soon as Peter heard the bell he dropped the knife and ran out of the back door. As he was leaving he pointed at Claire and said "I've not finished with you yet".

Claire managed to get up from the floor and answer the door to her mother. Her mother took the children to sit with a neighbour and then took Claire to the local hospital to be checked over. Claire and the children stayed with her mother last night. She thinks that Peter went to his parents' house. They live in a two-bedroom bungalow in 3 Carson Close, Clayton. Claire explained that she can't stay long at her mother's as she only has a one-bedroom housing association bungalow so it's too cramped.

I used devolved powers to grant Claire emergency legal representation and as the court had closed I advised her to remain at her mother's and return to the office tomorrow.
