Before Patsy can answer Edina puts the phone down and heads for Patsy's house. On Edina's arrival, some 30 minutes later, Patsy has sold the car.

- Does Edina have a valid contract with Patsy? Provide reasons for your answer.
- b. Assuming there is a valid contract what remedies would be available to Edina?

 - a. His neighbour, Daisy, has seen Angus' success and decides to establish a competing business. Unfortunately Daisy does not make many sales and so she embarks on a short advertising campaign. Angus is angered by the advertisements and seeks your advice as to whether he has any legal rights in respect of the following advertisements. For the purposes of this question you are to disregard any trade mark or passing off issues.

Advert 1: Come to Daisy's Luggage for exclusive leather luggage.

Just next door to Angus' Leather.

Advert 2: Daisy's Luggage – It's just like Angus' Leather only superior quality!

Advert 3: Daisy's Luggage – We only make our luggage from humane sources, unlike Angus' Leather who use hides from electrocuted cows!

b. Would it make any difference to your answer if Daisy honestly believed the advertisements to be true?

 - Explain the essential elements necessary to prove negligence. (Your answer should include an explanation of each element.)

However, you recently began working for James in respect of his own intellectual property filing programme. What professional conduct points need to be considered in this situation and why?
