### BACKGROUND FACTS

Student Bounty.com lan is an elite cyclist. Ian discovers that if he mixes crushed Arnott's Biscuits chock "Tim Tam" biscuits with Lagavulin single malt whisky and injects the resulting liquid thre times a day, it improves his cycling performance. He notices that it only works with single malt whisky not blends of whisky, and it works best with Lagavulin single malt whisky.



In creating his performance-enhancing invention, Ian was inspired by a Finnish feature film from the 1930's about an elite javelin thrower who injects himself with liquid whisky to improve his performance, and an academic study done in Switzerland about the performance benefits of dark chocolate for swimmers.

Ian is required to disclose the invention to the Commonwealth Anti-Doping Agency before he is allowed to participate in official races if he has injected himself with the performanceenhancing invention. This includes disclosing that the invention works best with Lagavulin single malt whisky. Everything he provides to the Commonwealth Anti-Doping Agency about his invention is labelled "Confidential".

lan then applies to register his patent with IP Australia. The patent specification refers to whisky but does not specifically refer to single malt whisky, or Lagavulin single malt whisky. lan's patent is registered.

Silvano reads the details of the registered patent and decides to start producing medical tablets and capsules made of the active ingredients of Arnott's Biscuits "Tim Tam" biscuits. He calls his product "Tim Tabs". Silvano sells the tablets and capsules with instructions how to mix the tablets and capsules with whisky. Silvano sells the tablets and capsules in packets that have a picture of the Arnott's Biscuits parrot (seen in the photograph above) on a bicycle.

Brian is an officer at the Commonwealth Anti-Doping Agency. He tells Graeme, the Australian-employed Australian-based representative of the Paris-based "Tour De France" cycling race about lan's invention, including that it works best with Lagavulin single malt whisky. The organiser of the "Tour De France" decides that it is within the rules of the "Tour De France" that cyclists who use lan's invention are entitled to cycle in the "Tour De France" race. Graeme thinks this is outrageous and leaks the invention, including the role of Lagavulin single malt whisky, to the Sydney Morning Herald newspaper.

- What are the "Tour De France" organiser's potential claims against Graeme for breach of confidence?
