General Guidelines:

It is important to remember that examiners are assessing the ability to communicate in writing.

When an essay is too long, markers are expected to mark the full essay. No penalty is considered, candidates will penalise themselves by becoming repetitive and therefore will be penalised for content. Indicate at the bottom: "Essay too long".

In most cases the grid can be used to penalise an essay that is too short.

The essay should be assessed in the usual way taking the following into account:

Essays:

100 to 150 words – no higher than F

50 to 100 – no higher than G

Fewer than 50 words – no higher than H

Indicate at the bottom: "Essay too short"

Guard against awarding unrealistically high marks to essays that stand out as being better than the others in a batch. An A essay should be outstanding. Look at the descriptors on the grid – exceptional development of topic, thought-provoking, striking, unusual, refreshing, excellent command of English, language evokes vivid images, virtually no errors.

Only award an H and 8/9 if the essay is very short (fewer than 50 words), totally irrelevant or unintelligible.

Be objective and allow for the candidate's background and personal views. Read the topic from the candidate's point of view.

Indicate all errors by using clear symbols (e.g. sp, wo, t, etc,). Refrain from underlining only.

Use ticks to indicate striking ideas or language.

All essays are marked according to the approved HG Umalusi grid out of 40. If no title is supplied: a deduction of 1 mark from the final mark. Indicate the deduction at the top and again next to the final mark.

Question 1: The generation gap.

- Discursive/Expository
- Candidates are expected to write about the generation gap between parents and teenagers.
- They should give examples to illustrate the differences that exist between parents and teenagers.
- Candidates must say what can be done to bridge this gap.

Question 2: Making provision for retirement

- Expository/Descriptive
- Candidates should discuss the importance of retirement planning.
- They should focus on the ways in which people can provide for their old age while they are still working, e.g. pension fund contributions, policies, buying property, starting a business while you are still working, etc.

Question 3: Opportunities for the disabled

- Argumentative
- One side of the argument should be taken.
- Candidates are expected to refer job, sport, education and transport.

Question 4: Looking after our environment

- Discursive/Expository
- Must mention the positive effects of looking after the environment.
- At least three things that can be done that can be done to protect the environment must be discussed.

Question 5: Absence makes the heart grow fonder

- Narrative
- Candidates are expected to write a story to illustrate the saying.
- The focus should be on the affection that people feel for those that they love when they are far away from them.

Question 6: Informal letter

- The letter should mention which professional the learner spent the day with.
- Candidates should describe their experiences on that day.
- They should say if the experience helped them to decide what they want to do.

- The letter must clearly state why the candidate is interested in the position.
- Qualifications and experience must be mentioned.
- Candidates must explain why they are well-suited to the job. (20)

(Date should be formally written out: e.g. 17 February 2005)

Topic -1 (Must come after the salutation)

Conclusion -1 (Yours faithfully / Yours sincerely are the only option)
