6.4 **WET OP WAPENS EN AMMUNISIE 1969 (WET 75/1969)**

6.5 **WET OP SEKSUELE MISDRYWE 1957 (WET 23/1957)**

6.4 **ARMS AND AMMUNITION ACT 1969 (ACT 75/1969)**

No person shall be in possession of any ammunition unless he is in lawful possession of an arm capable of firing that ammunition. (2)

6.5 **SEXUAL OFFENCES ACT 1957 (ACT 23/1957)**

The following persons are deemed to keep a brothel: any person who resides in a brothel, any person found in a brothel who refuses to disclose the name and identity of the manager thereof. (2)
