Read the following case study and answer the questions below.

The Green family has been living with relatives for six months, due to Mr Green having been made redundant and finding much lower paid work in a call centre.

Affordable housing has been difficult to find and the family are adapting to living in a new environment. They all miss their previous lifestyle, with two cars and expensive holidays. Nadia, four years old, has settled well in the local nursery and Sam, six years and six months, is enjoying making friends in the Primary school and joining in local activities. Jack, eleven years and six months, is often in hospital and has missed significant amounts of school due to a medical condition.

Home circumstances are overcrowded and not ideal. However, the children's mother tries very hard to keep to routines in order to keep the family healthy. She has registered them at a local Health Centre and takes them swimming regularly.

Mrs Green has had to sell her car, as they can no longer afford to run it, which means she has to walk with the children to and from school. This can be stressful as it involves a long walk on a country road. She finds living on a reduced income quite difficult and her in-laws' idea of discipline is very different from her own.

The children see much less of their father due to his new job's shift patterns and Mrs Green is feeling increasingly unhappy.
