“Il-Maltin dejjem jitekellmu l-Malti li kien ilsien Semitiku influwenzat hafna mill-Gharbi.....Iżda l-lingwa tal-Knisja u tal-Qrati, tal-kuntratti, tad-dokumenti, tal-kultura kienet il-lingwa Taljana.....Meta l-Inglizi gew Malta, kollox kien bit-Taljan.....L-Inglizi kellhom kull dritt li jagħmlu hilihom biex nitgħallmu l-Ingliz, imma ma kellhom l-ebda dritt, mingħajr il-kunsens tagħna, jordnawlna li ma għandniex nitgħallmu fl-iskejjel it-Taljan. L-ewwel Kummissjoni Rjali li giet Malta fl-1836 irrispettat il-pożizzjoni Maltija..... Iżda meta gie Keenan deherlu illi kien fl-interess tal-Maltin, speċjalment wara li Malta saret bażi navali u ċentru tat-traffiku tal-Mediterran, li jgħallmu l-Ingliz mill-ewwel klassijiet. Iżda billi rah diffiċli li t-tfal jgħallmu l-Ingliz u t-Taljan iddeċieda li t-Taljan kellu jispicċa u kellu jiġi studjat fit-tielet u fir-raba' klassi jekk xi hadd kien irid jgħallmu.... Ir-rapport ta' Keenan qajjem xenati kbar.”

B. Agra dan is-sors u wara wieġeb il-mistoqsijiet dwaru.

"I beg to inform you that Malta just now is not an agreeable residence. We have the cholera of a fatal type in our midst stalking about both at night and by day, taking its victims very suddenly, sometimes two or three in a single family. There is a general alarm among the population and, not to increase it, when a soldier dies, the body is buried in the early morning and not with the playing of the dead march as is customary when the public health is good. Again when the Communion is given to the sick, it is not taken from the church with the ringing of bells as is usual in other times but silently so that the people may not know how many are dying in the course of the twenty-four hours – and well it is so. Otherwise fear would have more victims than the cholera. Sicily, our nearest point of communication, will have nothing to do with us while the continental ports have put us in quarantine end.....I do not ask for leave of absence for under all circumstances I feel it my stern duty to remain where I am".

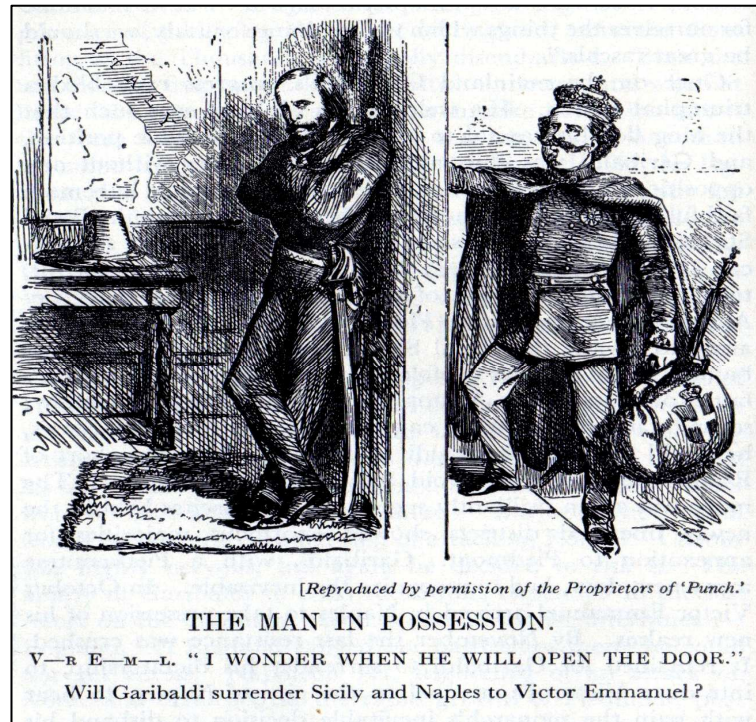

- Question: What were your hours of labour?
 Answer: From five in the morning till eight at night.
 Question: You had fourteen and a half hours of actual labour, at seven years of age?
 Answer: Yes.
 Question: Did you become very drowsy and sleepy towards the end of the day?
 Answer: Yes; that began about three o'clock; and grew worse and worse, and it came to be very bad towards six and seven.
 Question: How long was it before the labour took effect on your health?
 Answer: Half a year.
 Question: How did it affect your limbs?
 Answer: When I worked about half a year, a weakness fell into my knees and ankles: it continued, and it got worse and worse.
 Question: How far did you live from the mill?
 Answer: A good mile.
 Question: Was it painful for you to move?
 Answer: Yes, in the morning I could scarcely walk, and my brother and sister used, out of kindness, to take me under each arm, and run with me to the mill, and my legs dragged on the ground; in consequence of the pain I could not walk.
 Question: Were you sometimes late?
 Answer: Yes, and if we were five minutes too late, the overlooker would take a strap, and beat us till we were black and blue.

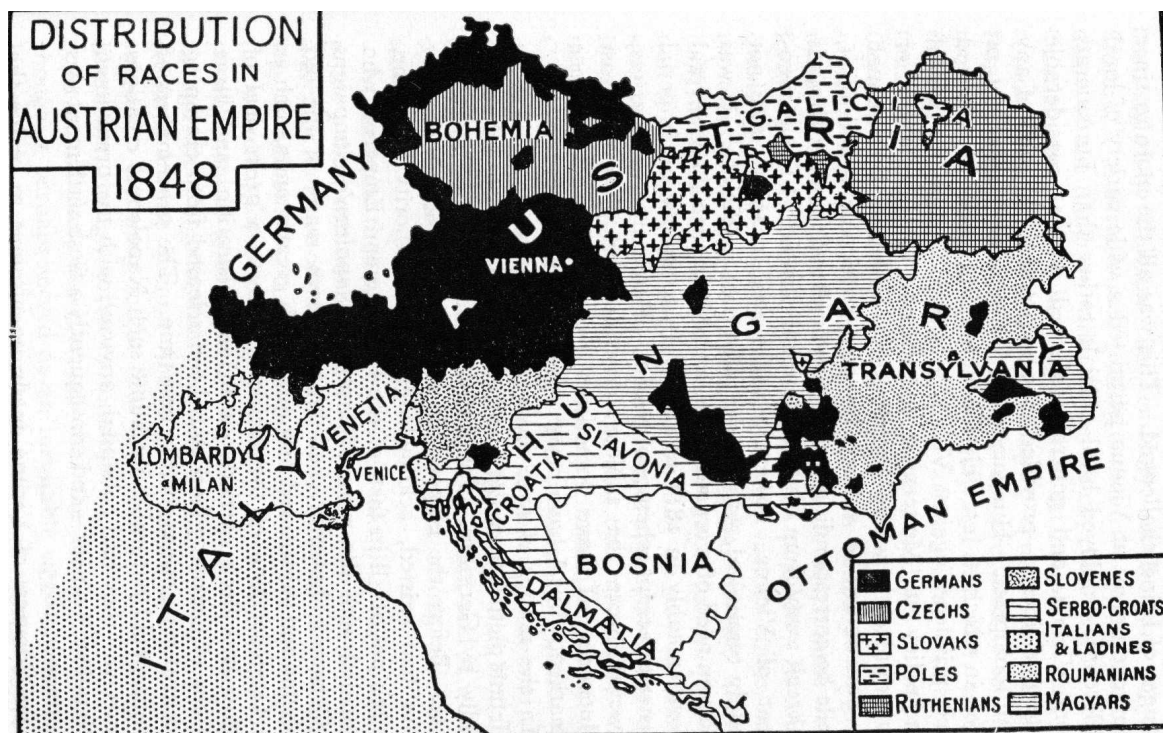
